- 4. Summary of listening sessions with staff Dan Keiser

- 5. Prayer and Devotion Dan Keiser showed an Andy Stanley video "Is It a Problem to Solve or a Tension to Manage?" Having an opposing thumb/index finger allows progress: humans can apply the correct amount of pressure and tension depending on the object. A great organization shouldn't resolve all problems and tension, they should manage them. There are multiple tensions in any organization, and progress is made when the tensions are leveraged (i.e., we can't fulfill all of our responsibilities at work and at home—there is a tension to find balance). New tensions are created when you resolve old tensions, new barriers to progress are created, too. Progress depends on the successful management of tensions.

Goal is not to win, but that progress-critical tensions never drop out of sight. Understand the upside of the opposite side, and understand the downside of your side. Be the champion of every side.
