- A. Preamble
  - 1. <u>In essential beliefs we have unity</u> "There is one Body and one Spirit...one Lord, one faith one baptism, one God and Father of all..." Eph.4:4-6

To his own master he stands or falls...So then, each of us will give an account of himself to God. So whatever you believe about these things keep between yourself and God..." Rom.14:1, 4, 12, 22
  - In all our beliefs we show love "If I have the gift of prophecy and can fathom all mysteries and all knowledge, and I have faith that can move mountains, but have not love, I am nothing." I Cor.13:2

  - <u>About the Holy Spirit:</u> We believe that a person is baptized by the Holy Spirit into the Body of Christ at the time of conversion; this baptism results in a believer being filled and supernaturally empowered for service through spiritual gifts. (I Cor.12:13; Rms.8:9-17; Rom.16:7-13; Eph.5:18; Gal.5:25; Jn.14:16-17)
  - <u>About the Bible:</u> We believe that the Bible is our supreme authority, and it is sufficient as our only rule of faith and practice. The Bible is God's Word to us. It was written by human authors under the supernatural guidance of the Holy Spirit and it is truth without any mixture of error. (I Tim.3:16; Heb.4:12; Rev.22:19; Pro.30:5; Ps.119:105, 160; 2 Pet.1:20-21)

- <u>About Salvation</u>: We believe that forgiveness of sin, salvation, and new life is made possible by the death of Jesus Christ on the cross. This salvation is by grace, through faith, and by the appropriation of the shed blood of Jesus Christ. (Rom.6:23; Eph.2:8-9; Jn.14:6; Jn.1:12; Tit.3:5; Gal.3:26; Rom.5:2)
- <u>About Eternity</u>: We believe there shall be a resurrection of the saved to eternal life and a resurrection of the unsaved to eternal punishment in hell.
