We agree to uphold the values, beliefs, and principles of GCA as stated in its Mission and Essential Beliefs. We have read, agree with, and will abide by these documents.

word to our life. Our prayer is for each child to be influenced by family, faculty and staff who are exhibiting Christ-likeness in and out of the classroom (Hebrews 10: 24-25, James 1:22)		
 We commit to positive, healthy communication/interactions inside and outside of the school by: leading with Christ-like love (1 Peter 4:8, Matthew 5:9, Romans 12:10), listening, praying for, and forgiving one another (James 1:19-20, Ephesians 4:32, Colossians 3:13, 2 Timothy 2:24), and encouraging one another in our Christian walk (Proverbs 27:17). 		
In resolving any question of disagreement or conflict, we agree to follow the biblical principles of conflict resolution (Matthew 18: 15-17), understanding we are all called to the ministry of reconciliation (2 Corinthians 5:18). We will be open to gather information from both home and school to fully understand the dynamics of the situation; This includes respectful, direct, and private communication with the person(s) involved (as opposed to sharing partial information with others, or even administrators not directly involved in the situation.) In the case of a classroom situation, families should approach the Teacher first and, only if those methods fail, bring the matter before leadership- Principal, and lastly Head of School.
